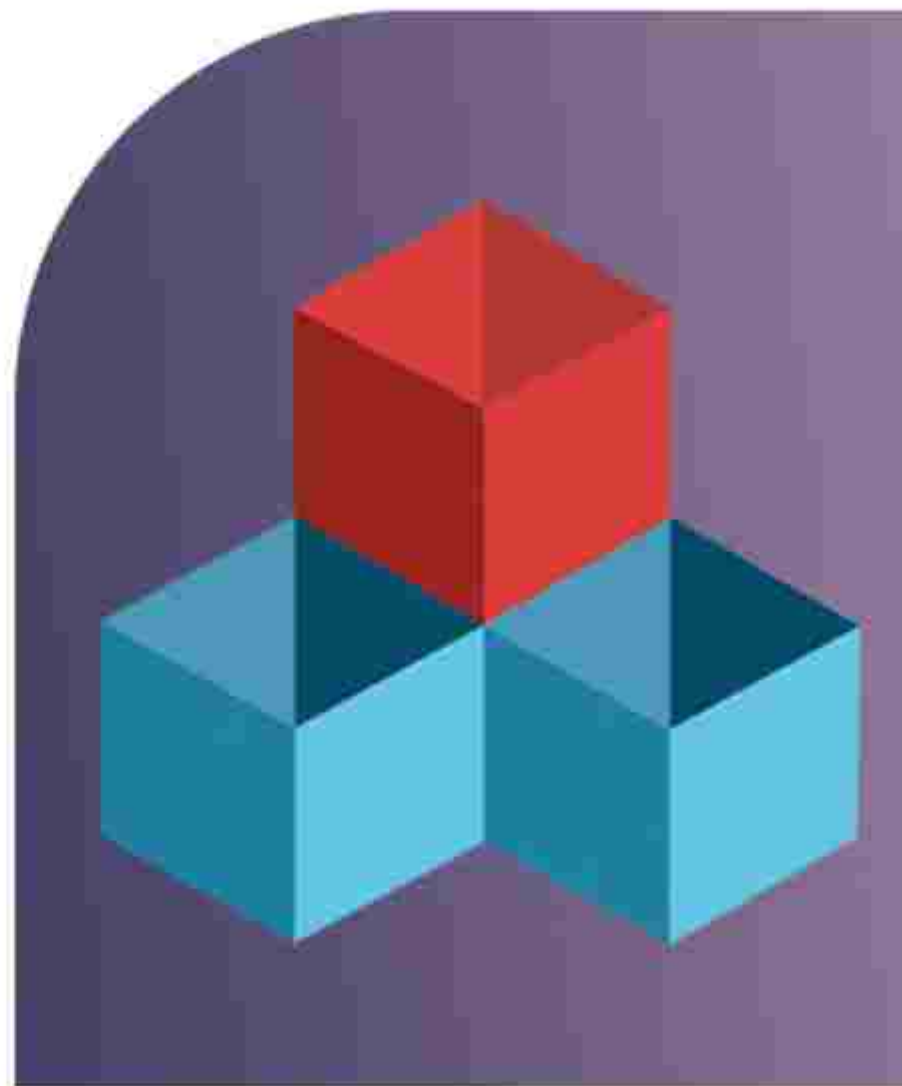

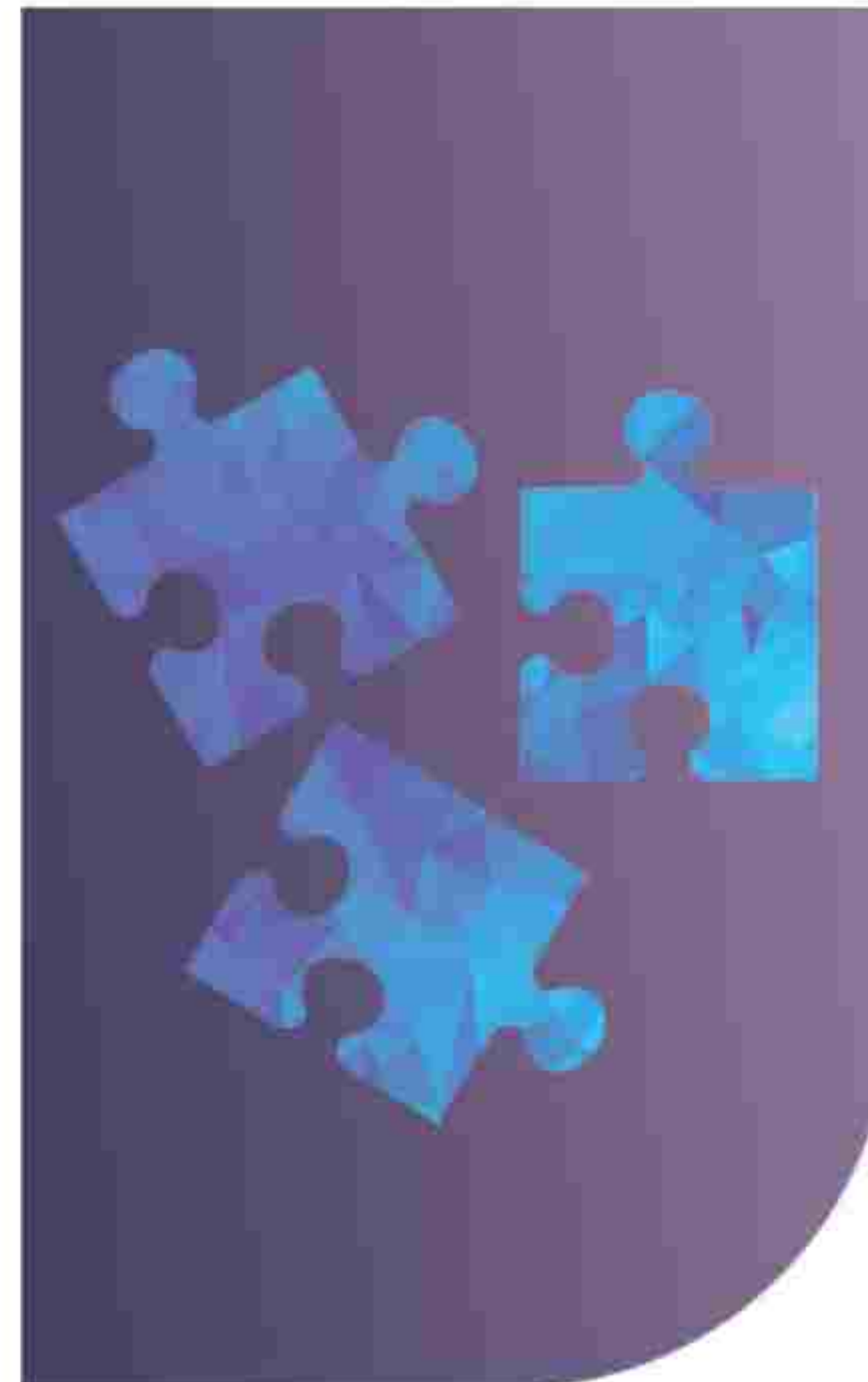

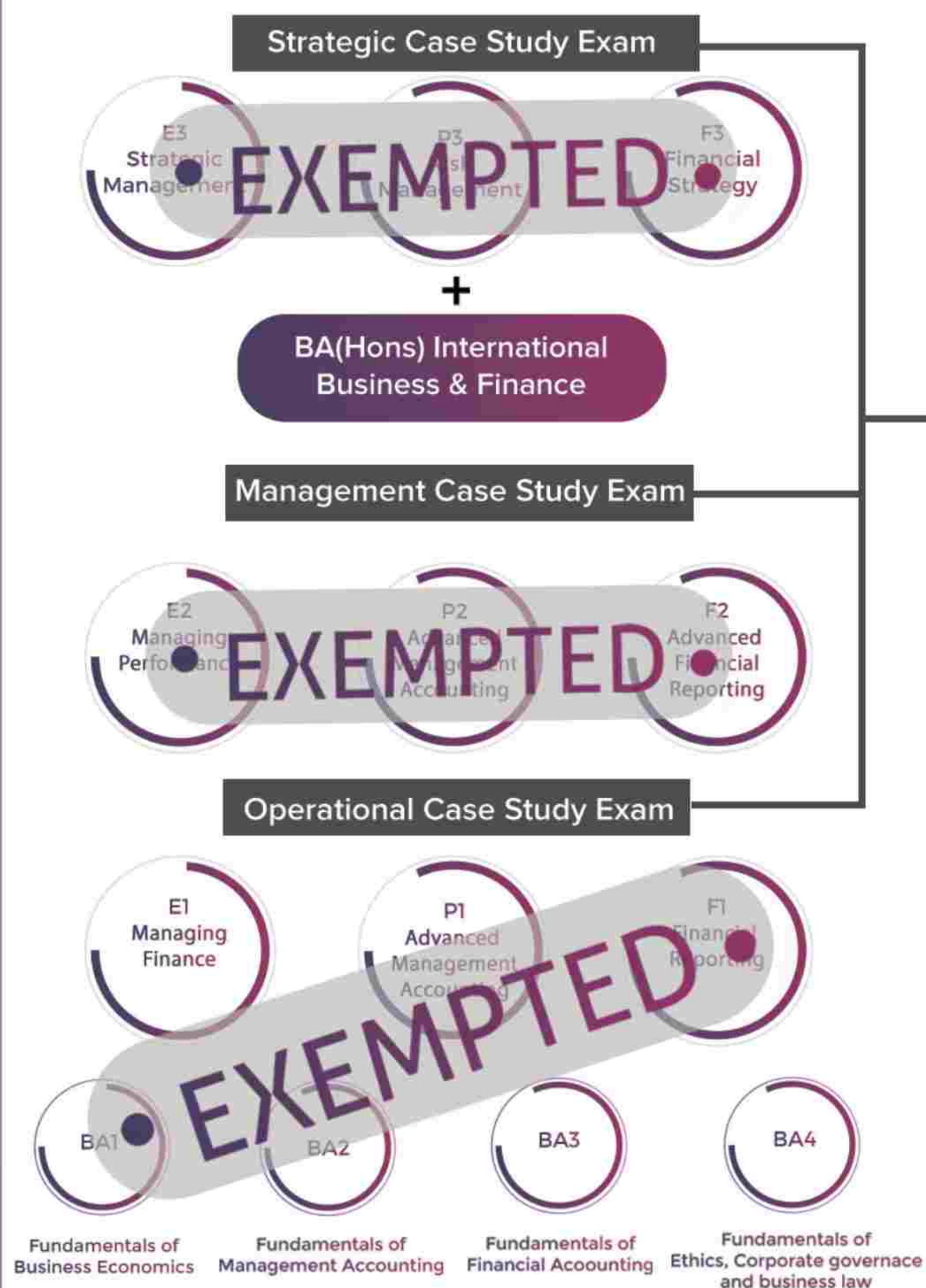

# ACCA Pathway

**Start the BA (Hons) Degree and avoid 9 ACCA exams (exempted)**

ACCA Knowledge and Skills Levels are exempted after completion of the 2nd Year of the degree programme. Students will be required to attempt only the 4 professional level examinations.



# CIM Pathway

Start the BA (Hons) Degree  
and avoid 6 CIM exams  
(exempted)

CIM, Certificate in Professional Marketing/ Digital Marketing (level 4), and Diploma in Professional Marketing/ Digital Marketing (Level 6) are exempted after the completion of the BA Hons degree programme. Students will be required to attempt only the final 3 exams in the postgraduate diploma in professional Marketing (Level 7) to acquire the CIM qualification.

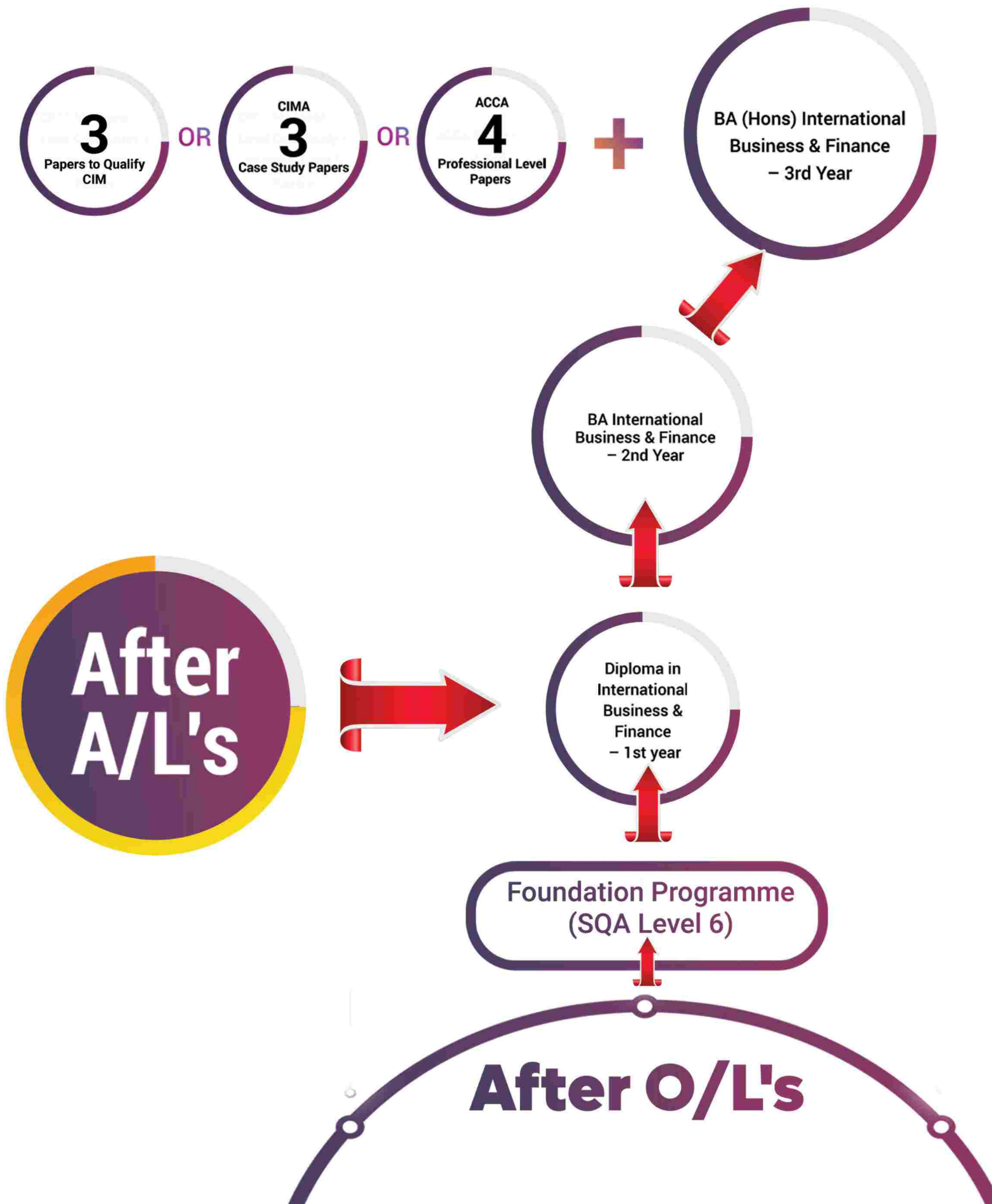

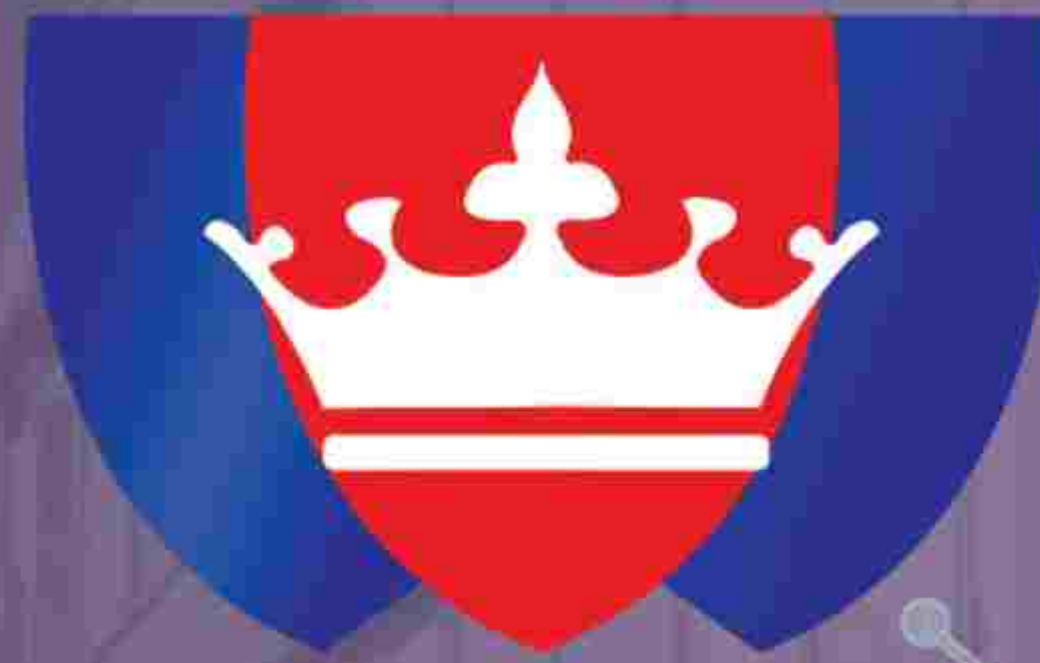
